- June 2021 saw strong dealflow across 94 transactions with the Payments (25 deals) and BankingTech (20 deals) sectors together representing approximately 50% of monthly deal volumes
- Following antitrust concerns on its \$5.3bn aborted acquisition of US-based Plaid, Visa turned to Europe announcing the acquisition of open banking leader Tink for €1.8bn. Leveraging Tink's API-based technology across Visa's broad network looks attractive albeit that antitrust concerns may also be relevant
- Roboadvisor nutmeg secured an attractive strategic premium announcing its £700m sale to J.P. Morgan despite modest double-digit £m revenues. driven by its 70%+ AUM growth in 2020 to £3bn+, investors' adoption of digital wealth platforms as well as JPM's drive to build its UK-based Chase technology platform
- Dutch payment services provider Mollie, driven by forecast doubling of processing volumes from €10bn in 2020 to €20bn in 2021, closed a €665m Series C funding round at a €5.4bn valuation led by Blackstone Growth to fund international expansion, technology platform investment as well as product development
