
• During December NovitasFTCL tracked 53 FinTech transactions comprising of 30 strategic acquisitions, 6 PE / Growth investments and just 17 VC rounds. BankingTech attracted the largest number of deals with 10, followed by Payments with 9 and InvestmentTech with 7.

• In Capital Markets, consolidator platform United Fintech acquired FX and digital assets specialist Cobalt. UK PE firm LDC invested in capital markets technology firm Etrading Software, specialising in the provision of market and reference data used by financial institutions. Lastly, bondIT received a \$14m strategic investment led by BNY Mellon, focused on the digitisation of fixed income investing. • In Payments, December saw a number of strategic acquisitions including POS terminal business Shift4 Payments' acquisition of payments facilitator (including e-checkout tools and mobile payments) SecurionPay for \$125.9m, circular economy Fintech Twig's asset deal with Gen Z neobanking start up Vybe as well as the merger of digital payment solutions provider POM with payment credit management software provider Mail to Pay.

• In BankingTech, personal credit health platform Updraft raised £108m in an unusual Series A round that comprised of £8m in equity and a further £100m in debt funding. Digital business bank Allica raised £100m from TCV, Warwick Partners and Atalaya, and Younited raised €60m at a valuation of over €1.1bn.
