


- During February NovitasFTCL tracked 65 transactions, comprising 22 strategic acquisitions, 8 PE / Growth investments and 35 VC rounds. InvestmentTech attracted the most deals with 15, followed by BankingTech with 14 and Payments with 13. 15 transactions involved Digital Assets.
- In InvestmentTech, the NatWest Group acquired workplace savings and investment platform Cushon for £144m, Parthenon Capital Partners made a major strategic investment into the Titan Wealth group (for an undisclosed amount), and Moonfare, the private equity investment platform extended its previously announced Series C led by Insight Partners.
- In BankingTech two companies achieved unicorn status, The Bank of London in a \$160m Series C investment round led by 14W and Mangrove Capital which valued the global clearing and transaction bank at \$1.1bn post-money, and Zopa which acquired BNPL


platform DivideBuy while also raising £75m in a deal led by SoftBank and Augmentum at a post-money valuation of £830m, or \$1.002bn based on the exchange rate at the time of writing.

- In Payments, Nexi acquired the retailer payments business of Banco de Sabadell, Paycomet, for €280m, while SBI Investments led a €26m Series A investment into Pliant, the corporate expense management platform.
- In FundsTech, institutional fund dealing and custody platform ifsam, advised by NovitasFTCL, was acquired by FNZ (subject to regulatory approvals), and fund platform Allfunds confirmed an unsolicited conditional €5.5bn cash and equity offer from exchange operator Euronext that was later withdrawn amid negative market reaction and questions on synergies.


