### EUROPEAN FORUS GLOBAL REACH JULY 2023 EUROPEAN FINTECH DEAL SUMMARY

• During July NovitasFTCL tracked 61 transactions, comprising 1 IPO, 22 strategic acquisitions, 8 PE / Growth investments and 30 VC rounds. Payments attracted the most deals (16), followed by BankingTech (12) and Capital Markets (7). In July, 11 transactions involved Digital Assets.

• In Payments, GTCR announced the acquisition of a 55% stake in payment processing solutions provider Worldpay from FIS, who retain a 45% stake, in a transaction valued at \$18.5bn with GTCR committing up to \$1.25bn of additional equity capital into Worldpay for M&A opportunities. B2B cross-border payments and foreign exchange specialist CAB Payments listed on the London Stock Exchange at a conditional offer price of £3.35 per share resulting in an initial market capitalisation of c. £850m and BCC Pay, via its backers Banca ICCREA and FSI Funds, agreed to acquire the payment operation, a subsidiary of Banco BPM Gruppo, through a €500m LBO leaving Banco BPM, Banca Iccrea and FSI as 28.6%, 28.6% and 42.8% shareholders respectively.


In BankingTech, Bowmark Capital acquired UK lending

technology platform Lendscape, deal terms were not disclosed. Netherlands based digital neobank Bunq raised  $\notin$ 45m at a valuation of  $\notin$ 1.6bn in a round led by Pollen Street Capital, and the embedded finance, banking-as-a-service platform Solaris raised  $\notin$ 38m from existing investors in a series F round that reportedly valued the business at  $\notin$ 1.6bn, roughly in-line with its last external fundraise in 2021, and approximately 12x 2022 revenues.

• In the Data & Analytics vertical, Francisco Partners acquired leading provider of macroeconomic and financial data (and software) Macrobond from Nordic Capital for an estimated €700m. Nordic Capital had backed the business since 2018. With Intelligence, a provider of data intelligence and connectivity to the asset management industry, got majority backing from Motive Partners (£400m). Its existing backer ICG also invested further. In minority transactions Balderton led a \$57m Series B into Sylvera (ML tools tracking performance of carbon offsets), and 73 Strings (valuation and portfolio monitoring solutions for the private capital industry) raised a \$10m Series A led by Blackstone and FISV.


