


- During September NovitasFTCL tracked 58 deals, comprising of 20 strategic acquisitions, 8 PE / Growth investments, and 30 VC rounds. BankingTech attracted the largest number of deals with 20, followed by Payments with 13, and InsurTech with 7. Eight transactions involved Digital Assets.
- In BankingTech Zopa raised a further £75m from Softbank with participation from Silverstripe, Augmentum and Uprising. Curve raised an additional £58m in Series C funding from Outward, Cercano Management and IDC Ventures, and new UK mortgage lender Perenna raised a \$52m round led by Silverstripe. In the venture space French embedded finance firm Swan raised a €37m Series B led by Lakestar.
- In Payments, trade acquirers remained active with Fiserv acquiring the remaining 49% in European Merchant Services to add to its existing 51% stake, Alpha Group acquiring corporate treasury software business Cobase and Clear Junction acquiring crypto on/off ramp Altalix. Growth capital investors were also busy with HPE Growth increasing its investment in payments orchestration platform AEVI, Visa investing in payments technology platform Form3 and Susquehanna Growth Equity investing in payment / spending platform Hyperjar's \$24m Series A.
