
• During March NovitasFTCL tracked 69 transactions, comprising of 22 strategic acquisitions, 13 PE / Growth investments and 34 VC rounds. BankingTech attracted the largest number of deals with 18, followed by Payments with 14 and RegTech with 10. Nineteen transactions involved Digital Assets.

• In BankingTech, Monzo raised £340m in a round led by CapitalG, Alphabet's independent growth fund, at a post-money valuation of £4bn. Savings and investment platform Flagstone raised £138m from Estancia Capital, and banking-as-a-service platform Solaris received €96m in growth capital in a round led by SBI. Bain Capital acquired lending tech platform Finova, and the UK mortgage business of IRESS.

• In payments, travel industry platform Amadeus acquired the B2B travel payments specialist Voxel for c. €118m to integrate into payments division Outpayce, local payments platform PPRO announced €85m funding from new and existing investors including Eurazeo, PayPal and HPE Growth to grow further in key strategic markets and GoCardless acquired account-to-

account and open banking specialist Nuapay for c. \$36m to build its presence in indirect channels including Independent Software Vendors and Payment Service Providers.

March was a particularly active month in the digital assets space. Euroclear acquired a stake in IZNES, a pan-European funds marketplace based on blockchain technology. Numerous interesting fund raises took place in the venture category, amongst which Baanx (FCA-authorised crypto payments) raising a \$20m Series A including Ledger, the Tezos Foundation and the British Business Bank; ClearToken (digital assets clearing house) raising an institutional \$10m round from Laser Digital, Flow Traders, GSR, LMAX Digital and Zodia Custody; D2X (institutional crypto derivatives exchange) raising a \$10m Series A led by Point72 Ventures; Midas (asset tokenization protocol) raising \$8m led by BlockTower, HV Capital and Framework Ventures; and Entangle (cross-chain interoperability protocol) receiving a strategic investment from Consensys.
