• During June NovitasFTCL tracked 67 transactions, comprising of 17 strategic acquisitions, 8 PE / Growth investments and 42 VC rounds. BankingTech attracted the largest number of deals with 13, followed by Payments with 12 and InvestmentTech with 9. Sixteen transactions involved Digital Assets.

• In BankingTech M&A, Ageras, an integrated banking and accounting platform acquired French mobile banking app and SocGen subsidiary Shine, and TeamSystem, the Italian provider of digital solutions to SME's acquired Change Capital, an SME financing platform focused on the Italian market. There was a single growth investment from Latour into Swedish personal finance simulation platform Econans, and notable venture rounds included re:cap's €15m Series A round led by Entrée Capital, working capital financing platform Hero raising €11m in a round led by Valar Ventures, and digital bank Curve securing an undisclosed amount of funding from Samsung NEXT ventures.


• In Payments, Klarna divested Klarna Checkout to a group of investors for an estimated €300m. Financial management system SaaS vendor AccountsIQ attracted a €60m Series C round provided by Axiom Equity.

• In InvestmentTech, AssetMark acquired \$12bn in assets from Morningstar Wealth's Turnkey Asset Management Platform (TAMP), investment data platform Finbourne raised \$55m in Series B funding from Highland Europe and AXA Venture Partners, and crypto custody platform Zodia Custody received an investment from the venture arm of National Australia Bank to support its expansion into the Australian market.

• Otherwise, Blackrock, leading alternative assets data vendor, acquired Preqin for £2.55bn, and Robinhood acquired long-standing crypto exchange Bitstamp for c.\$200m in cash.
