• During August NovitasFTCL tracked 50 transactions, comprising of 19 strategic acquisitions, 13 PE / Growth investments and 18 VC rounds. Payments attracted the largest number of deals with 15, followed by InvestmentTech with 9 and BankingTech with 8. Nine transactions involved Digital Assets.


• In payments, Revolut announced a secondary share sale to new and existing investors to provide liquidity for employees at a \$45bn valuation, led by Coatue, D1 Capital Partners and Tiger Global, CloudPay, the global payroll and payment solutions provider, announced a \$120m funding round led by Blue Owl Capital and Germany private equity house SGT acquired, consolidated and listed three internet payment service providers, Funanga AG, Campamocha Ltd. and Surfer Rosa Ltd under the new name "The Payments Group Holding". • BankingTech recorded 8 transactions this month including ColCap's acquisition of Molo, a UK based digital mortgage lender, US cloud storage platform Box acquired Alphamoon, an Al document automation and data extraction solution based in Poland, and on the fundraising side Denmark's Kompasbank, an SME focused neobank, raised a further €12m to support its continued growth.

• In other verticals, Bridgepoint completed the acquisition of leading financial services consulting firm Alpha FMC, Pollen Street Capital acquired Keylane Group (a SaaS core insurance software provider) from Waterland Private Equity, and Permira took a majority stake in BioCatch (a digital fraud detection and financial crime prevention vendor).


