
• During December NovitasFTCL tracked 67 transactions, including 25 strategic acquisitions, 10 PE / Growth investments and 32 VC rounds. Payments recorded the largest number of deals with 21, followed by BankingTech and InvestmentTech with 12 each. 17 transactions involved Digital Assets.

• In Payments, a consortium of investors comprising Towerbrook, JC Flowers and Railsr announced an offer for Equals Group, the international multi-currency banking and payments business, valuing the business at c. £283m, following Equals' review of strategic options announced in November 2023. The consortium will look to combine the Equals business with Railsr's embedded finance platform. Elsewhere, Mambu acquired SEPA payment technology platform Numeral and chargeback mitigation platform Justt raised \$30m Series C venture funding led by Zeev Ventures. • This month BankingTech recorded 12 transactions including the FIS acquisition of UK working capital finance platform Demica, for a reported £237m. Two well known peer-to-peer lending platforms raised funds with UK based Zopa receiving €82m in a round led by A.P Moller, and German lender Auxmoney raised €50m from Portage and Centerbridge.

• Other notable deals this month include CPP's €460m investment into the German regulatory reporting platform Regnology, and Upvest, the German investment API platform, raised a €100m Series C round led by Hedosophia. In other news, it was also reported that eToro, the Israel-headquartered mobile trading platform, filed to list in the US rather than in the UK.
